

INT. CLASSROOM - DAY

The kids are in school.

MR. GARRISON

Okay, children, let's take our seats. We have something very important to discuss. Due to recent events around the country I have been instructed to teach you all about sexual harassment in school.

The kids just stare.

KYLE

About what?

MR. GARRISON (cont'd)

Now, does anybody know what sexual harassment means?

Cartman raises his hand.

MR. GARRISON (cont'd)

Yes, Eric?

CARTMAN

When you're trying to have intercourse with a lady friend, and some other guy comes up and tickles your balls from behind.

Garrison stares at Cartman.

MR. GARRISON

No Eric, that's not what I'm talking about! The school board has sent over a special guest to teach us all about sexual harassment in schools. Please welcome Peetie The Sexual Harassment Panda.

Garrison steps aside and a guy in a Panda suit takes his place. The kids just look confused.

A song starts and Sexual Harassment Panda does a gay little dance.

PANDA SONG

Who lives in the east
neath a willer tree?
Sexual Harassment Panda!
Who explains sexual harassment
To you and me?
Sexual Harassment Panda!
Don't say that

Don't touch there
Don't be nasty
Says that silly bear
He's gonna tell you
What's right and wrong!
Sexual Harassment Panda!

SEXUAL HARASSMENT PANDA
Hi, boys and girls!

The kids look confused.

MR. GARRISON (cont'd)
(Angry)
Say HI to Sexual Harassment Panda!!

KIDS
(Half-assed)
Hi, Sexual Harassment Panda.

Panda pulls out large picture cards and holds them out in front of himself. The drawing is of two little pandas outside.

SEXUAL HARASSMENT PANDA
Did you know that when one little panda pulls on another little panda's underwear... That's sexual harassment. That makes me a saaaaaad panda.

KYLE
This is freaking me out, dude.

He flips to another card.

SEXUAL HARASSMENT PANDA (cont'd)
And when one little panda puts his furry little willy in a another panda's ear... That makes me a VERY SAAAD PANDA. Now, I'm going to pass out these booklets, and we're going to go through each and every sexual harassment law.

KIDS
AWWW!

EXT. SCHOOL - DAY

5 hours later.

INT. SCHOOL - DAY

SEXUAL HARASSMENT PANDA
Article thirty six, section nineteen.
'One panda may not make sexual comments about another panda's

appearance. If said Panda-

STAN

Aw, dude, get me out of here.

CARTMAN

I think Sexual Harassment Panda is cool.

STAN

You would think that, you little ass sucker.

CARTMAN

What did you call me?

STAN

An ass sucker. It means you suck ass. When you see an ass you suck it. You're an ass sucker.

CARTMAN

That does it! I'm SUING YOU FOR SEXUAL HARASSMENT!!

PANDA

Uh oh!

STAN

What?

CARTMAN

You have sexually harassed me for the last time!

(Holding up workbook)

It says right here, that now I can sue you and take all of your money!

PANDA

That's right, he can.

STAN

No you can't, you little ass sucker.

CARTMAN

Ooh! He did it again! You all heard him!

PANDA

(reading)

'The first party of the first panda may sue the second party panda unless that panda was said panda of before mentioned panda.'

EXT. COURTHOUSE - DAY

Marching DRUMS sound and flags wave in front of the courthouse.

INT. COURTROOM

It looks kind of like Judge Judy. Cartman stands behind one podium with a nice suit and tie. And Stan stands behind the other one in his normal clothes.

Kyle is sitting down behind Stan. And other people are in the courthouse, awaiting their trials.

JUDGE

This is Cartman vs. Marsh, case number 3433. What is your complaint, Mr. Cartman?

CARTMAN

Your honor, my lawyer is just parking the car he should be in any second...

KYLE

Dude, he got a lawyer!?

The door opens and Kyle's dad walks in with a briefcase.

KYLE'S FATHER

Sorry I'm late.

KYLE

DAD?!

KYLE'S FATHER

Oh, hi Kyle.

JUDGE

Alright, let's move this along, shall we? Now, Eric Cartman... You claim that Stan Marsh has sexually harassed you in school.

CARTMAN

(Too close to mic)
That is correct, my honor.

STAN

Oh, whatever.

Kyle's dad leans down and whispers in Cartman's ear.

CARTMAN

He said talked about having oral sex with my ass.

STAN

I called you an ass sucker!!

CARTMAN

Yes, that was it.

(Starting to cry)

I was so upset... I couldn't concentrate the rest of the day. And the way his eyes kept looking at me. Slowly going up and down my body. Like he was undressing me with his eyes...

STAN

WHAT?! Cartman! You call people names all the time!!

KYLE'S FATHER

As you can see, your honor, my client is too upset to continue.

JUDGE

Mr. Marsh, what do you have to say?

Stan just stands there, frozen for a second.

STAN

What do you mean?

JUDGE

I need to hear your defense.

Stan looks at Kyle. Kyle just shrugs.

STAN

Uh... I'm eight?

JUDGE

Alright this seems pretty open and shut. Stan Marsh under the new sexual harassment in schools law, I am forced to find you guilty.

STAN

Huh!?

KYLE'S FATHER

Alright, we did it!

CARTMAN

Hooray!

JUDGE

Since the defendant is under age, and has no monetary resources, it is the judgement of this court, that fifty percent of Stan Marsh's belongings are to be handed over to Eric Cartman immediately.

STAN

I have to give him half my stuff?!

CARTMAN

Sweet.

INT. STAN'S ROOM

The bailiff, Stan, Cartman and Kyle's dad stand in Stan's room. Cartman is looking over Stan's things, deciding what he wants.

The bailiff puts things into a large basket as Cartman points at them.

CARTMAN

Let's see... I want that Climb Criminy game... And that Power Jim Doll...

Stan looks dejected as the bailiff picks up the Power Jim Doll and puts it in the basket with Stan's other belongings.

CARTMAN

And, let's see... Do you really like this remote control truck?

STAN

Yeah, dude, that's my favorite toy.

CARTMAN

Oh, well I'll just take that then...

Cartman puts the truck in the basket.

CARTMAN

And what about this? Is this one of your favorites?

Stan thinks for a second.

STAN

Uh, no! I hate that toy!

Cartman cocks his head.

CARTMAN

Oh, then you mind if I take it.

Cartman puts it in the basket.

STAN

DAMMIT!

The bailiff hands Kyle's dad a football and a train.

BAILIFF

Here you go. As your legal fee, you

can choose between the green cho-cho
or the squishy football.

Cartman walks, slowly pointing out things. The bailiff
and Kyle's father walk with him.

KYLE'S FATHER

(Walking)

You know, Eric, I've been thinking...

CARTMAN

(Walking)

Uh-huh.

(To bailiff)

That model airplane kit.

(To Kyle's dad)

Go on.

KYLE'S FATHER

You know, the people really
responsible for your harassment is the
public schools. Perhaps we should sue
them next.

CARTMAN

Why should I sue the schools?

KYLE'S FATHER

Well, because they're the ones that
let this harassment go on... And they
have a lot more money. I think we
could get a lot more out of this than
half of Stan's belongings.

CARTMAN

Interesting...

(To the bailiff)

Ooh, Stan's asthma inhaler! I want
that!!

INT. COURTROOM

We are back in court. For now we see only the female
Judge.

JUDGE

Answer the question. Did you KNOW that
sexual harassment was going on in the
classroom?

Now we see that Mr. Garrison is in the witness box.

MR. GARRISON

No! I had no friggin' idea.

Kyle's dad steps forward.

KYLE'S FATHER

Mr. Garrison, do you know the definition of sexual harassment?

MR. GARRISON

Of course! And so does Mr. Hat! We do NOT TOLERATE SEXUAL HARASSMENT!!

JUDGE

YOU are the witness here, Mr. Garrison, not Mr. Hat.

MR. GARRISON

I'm sorry, toots.

KYLE'S FATHER

Did you or did you not hear my client being called an ass sucker?

MR. GARRISON

Yes.

KYLE'S FATHER

And you did nothing?

MR. GARRISON

He IS a little ass sucker.

MURMURS through the crowd. Stan CHEERS. The judge bangs her gavel.

JUDGE

Mr. Garrison I will remind you that we are in court!

MR. GARRISON

Okay, baby, I'm sorry.

INT. COURTROOM - LATER

Principal Victoria is now on stand.

KYLE'S FATHER

Principal Victoria, were you aware that my client was being harassed at your school?

PRINCIPAL VICTORIA

Well, not any more than any other student.

KYLE'S FATHER

Oh, so you admit that harassment goes on?!

PRINCIPAL VICTORIA

I don't know!

KYLE'S FATHER
YOU DON'T KNOW?! YOU'RE THE
PRINCIPAL!!

PRINCIPAL VICTORIA
I CAN'T BE AROUND EVERY SECOND!!

KYLE'S FATHER
SO IT DOES GO ON!!!

PRINCIPAL VICTORIA
ALRIGHT! ALRIGHT! I KILLED HIM!! I HIT
HIM OVER THE HEAD AND I CUT UP THE
BODY!! I TRIED TO BURN IT BUT IT
WOULDN'T BURN! OH THE SMELL OF IT!! I
PUT THE LEGS IN GARBAGE BAGS AND HID
THE TORSO UNDER A BRIDGE. I HAD TO DO
IT! AAAGGH!! OH GOD!!!

She breaks down, sobbing. Everyone just sits in silence.

KYLE'S FATHER
Principal Victoria, was Eric Cartman
called an ass sucker, yes or no?

She collects herself.

PRINCIPAL VICTORIA
(Sniffing)
I believe so, yes.

A shocked MURMUR goes through the crowd.

INT. COURTROOM

KYLE'S FATHER
Last, I'd like to bring up my expert
witness, Sexual Harassment Panda.

Sexual Harassment Panda walks to the stand as his THEME
plays.

PANDA SONG
Who lives in the east
neath a willer tree?
Sexual Harassment Panda!

KYLE'S FATHER
Expert witness, did South Park
Elementary allow sexual harassment to
go on?

SEXUAL HARASSMENT PANDA
Well, when one little panda asks
another little panda to perform oral
sex... That is Sexual Harassment.

KYLE'S FATHER
And who is to blame?

SEXUAL HARASSMENT PANDA
I'm afraid the law states that the
school must be held responsible.

KYLE'S FATHER
There you have it! Straight from the
horse's mouth!

SEXUAL HARASSMENT PANDA
Panda.

KYLE'S FATHER
Panda's mouth.

INT. COURTROOM - LATER

Everyone stands as the judge walks in and sits down.

JUDGE
After careful review, it is the
judgement of this court that South
Park elementary pays Eric Theodore
Cartman one point three million
dollars in damages.

Everyone GASPS.

KYLE'S FATHER
ALRIGHT!! WE DID IT, ERIC!!

Eric starts to dance in place.

CARTMAN
Get down! Get down and party! I
seriously!

Stan and Kyle look at each other, disappointed.

EXT. KYLE'S NEW HOUSE

Moving Vans are outside of a very large house. It looks
just like all the other houses in South Park, except that
it's huge.

Kyle's father calls out to some movers who are carrying a
large television.

KYLE'S FATHER
That goes in the master bedroom!

Kyle walks up.

KYLE'S FATHER

Well Kyle, what do you think of your new house?

KYLE

It's... Big.

KYLE'S FATHER

Yes. It is BIG, isn't it. It is very... BIG.

KYLE

Dad... If the school has to pay you and Cartman one point three million dollars... Where does that money come from?

KYLE'S FATHER

Well, Kyle, schools have lots of money. You see, we all pay taxes, and part of that tax money goes to public schools. And it's from that money that we got our one point three million.

Kyle thinks as the movers continue to haul stuff into the house.

KYLE

And you don't see a problem with that?

Kyle's dad thinks for a long time.

KYLE'S FATHER

No. It's a very fragile system that nature has designed. All things flow into each other.

KYLE

You're trying to confuse me now, aren't you?

KYLE'S FATHER

Sort of, yeah.

INT. CLASSROOM - DAY

Garrison is standing at the head of the class. There are no posters on the walls, and Garrison's desk is gone. Nothing is written on the chalk board.

MR. GARRISON

Okay, children, there's a few changes being made here at school, but lessons will go on as normal. Any questions? Yes, Stan?

REVEAL the children, who are all sitting on the floor instead of their desks.

STAN

Where's our desks?

MR. GARRISON

Right, desks... Well, a lot of cuts had to be made since the school's funding is short for lawsuits.

STAN

You see, Cartman?! You see what this has done?!

CARTMAN

All I know is I got this sweet digital watch, and these cool shoes... I'm telling you guys, suing people kicks ass.

CLYDE

Wow, I wanna sue somebody!

BEBE

Me too! I'm gonna get a lawyer!

KIDS

YEAH!

MR. GARRISON

Well, let's just try to cope with the changes and do our school work. Now, I'm going to write a sentence and I want you to tell me the noun...

Garrison goes to the chalkboard and starts scratching deeply into it with a nail. SCREEEECH!!! SCREEEEEECHH!!

KIDS

AGAHAGHHH!!!!

MR. GARRISON

I know, I know, I'm sorry, children but we can't afford chalk anymore. I have to write on the chalkboard with this rusty nail.

(Back to chalkboard)

Anyway, children, in the sentence on the board 'The Ball Is Red'...

Garrison starts writing again. SCREEECH!! SCREEECH!!!

KIDS

AAAGHGHG!!!!

ACT II

COMMERCIAL

INT. KYLE'S DAD'S OFFICE

Kyle's Dad leans against his desk. Law books line the shelves in the B.G. A briefcase sits on the desk, open.

KYLE'S FATHER

Kids? Are you tired of being harassed at school? Sick of being called a homo? A farty-pants? A butt-face? Then call ME, Kyle's dad, and I'll help you-
(closing the lid)
close the lid on sexual harassment in school!

CUT TO:

CLOSE UP on Bebe outside.

BEBE

After a boy in my class tried to put his tongue in my mouth, I knew I needed legal help...

PULL BACK to reveal that BEBE is on a new, bright, shiny bicycle.

BEBE

Kyle's Dad helped me get a 1.6 million dollar settlement and this bright, new, shiny bicycle! Thank you, Kyle's Dad!

We see Clyde on a yacht.

CLYDE

(Reading badly)
Kyle's dad got me 1.4 million and he can do it for you too! Just look at all these beautiful girls!

Women in Bikinis come out and hand Clyde drinks.

CUT TO:

KYLE'S FATHER

So call ME! Kyle's dad! Because it is NOT about money, its about... wait... What am I saying... Call me!

A SONG STARTS.

CHORUS

Kids picking on you
Don't be sad

Just sue their asses
With Kyle's dad

Kyle's dad freeze frames.

INT. SCHOOL BOARD ROOM - DAY

Five people are at a long table. A large sign behind them reads 'School Board'.

PRESIDENT

Alright, what other cuts do we have to make to the school budget?

ASSISTANT

Uh, next we have Tom Morris, he plays Sexual Harassment Panda at the schools.

PRESIDENT

Oh right. We certainly can't afford him anymore.

ASSISTANT

I warn you, Mr. Evans, Tom Morris takes his job a little seriously.

Sexual Harassment Panda walks in the room.

SEXUAL HARASSMENT PANDA

Hello Sexual Harassment Cubs!

PANDA SONG

Who lives in the east
neath a willer tree?
Sexual Harassment Panda!

PRESIDENT

Have a seat, Mr. Morris.

SEXUAL HARASSMENT PANDA

Who?

PRESIDENT

Uh... Sexual Harassment Panda.

SEXUAL HARASSMENT PANDA

Oh, alright!

Sexual Harassment Panda sits down. The President and Assistant exchange looks.

PRESIDENT

Mr. Morris... We at the school board have been thinking... And we've decided that perhaps a PANDA isn't the BEST way to explain sexual harassment

to children.

Sexual Harassment Panda just turns his head.

ASSISTANT

You see, Mr. Morris, we believe that a PANDA doesn't really have anything to do with sexual harassment... At all.

There is a long silence.

PRESIDENT

Well, I'm afraid we're just going to have to let you go.

Sexual Harassment Panda drops his head.

SEXUAL HARASSMENT PANDA

I'm a saaaaaaad panda.

INT. COURTROOM - DAY

The kids are back in court. This time, Cartman is at the defense table, and Pip is standing with Kyle's dad.

JUDGE

Eric Cartman, it is the judgement of this court that you sexually harassed Pip Phillip at school.

CARTMAN

No way!!

PIP

I won!

CARTMAN

This is ridiculous!

JUDGE

You asked Pip to suck your... You know what. You must give Pip half your stuff. And the school must give Pip 1.6 million dollars.

PRINCIPAL VICTORIA

Oh dear God!

Kyle's dad pats Pip on the back.

KYLE'S FATHER

Wow, I'm good!

JUDGE

NEXT!

Wendy and Craig step up to the podiums.

CRAIG
This girl touched my thigh.

The judge slams her gavel.

JUDGE
Half her belongings. School is sued
for 2.1 million.

PRINCIPAL VICTORIA
We're ruined!

JUDGE
Next!!

Mr. Mackey and Tweek step up to the podiums.

MR. MACKEY
Uh, your honor, This young man
commented on the shape of my ass.

TWEEK
AGH!

Judge slams her gavel.

JUDGE
Half his stuff. Two million from the
school.

PRINCIPAL VICTORIA
(Passing out)
WAGH!

INT. CLASSROOM - DAY

Mr. Garrison walks in and goes directly to the
chalkboard.

MR. GARRISON
Okay, children, let's all take our
seats... We have a lot to learn today.

Garrison turns to the kids and looks confused.

REVEAL the kids, sitting on the floor. Kyle's Dad is
standing amidst them, holding his briefcase.

MR. GARRISON
Okay... Uh, Clyde, can you tell me
when Ulysses S. Grant was President?

CLYDE
Um...

KYLE'S FATHER

Don't answer that!

Garrison thinks.

MR. GARRISON
Uh, Craig how about you?

Kyle's dad leans down and whispers in his ear.

CRAIG
Uh-huh... Okay...
(To Mr. Garrison)
I refuse to answer on the grounds that
it may incinerate me.

KYLE'S FATHER
Psst psst psst.

CRAIG
'Incriminate'.

MR. GARRISON
Okay, children, I'm having a real
problem with you all having lawyers.
It is really disrupting my class time.

Kyle's father leans in and whispers in his ear.

MR. GARRISON (cont'd)
Uh-huh... Right... Oh, I see.
(To students)
Kids what I meant to say is that I
fully condone you all having lawyers
and support your legal recourses in
every way.
Now, let's get back to Ulysses S.
Grant... If that's okay with you...

INT. CAFETERIA - DAY

The boys are in lunch line.

CHEF
Hello there, children!

BOYS
Hey Chef.

CHEF
How's it going?

STAN
Bad.

CHEF
Well they're about to get worse. All I
can serve you for lunch is lumpy

potatoes.

Chef holds up a spoon with spoo on it.

CARTMAN
Lumpy potatoes?! OH NO!

CHEF
Sorry children, all my funding's been cut.

CARTMAN
Oh my GOD! You guys have to do something!!

Stan and Kyle glare at Cartman.

STAN
Chef, how can we stop all these sexual assment lawsuits?

CHEF
I don't know, children. Why don't you ask your dad? He's a lawyer, ain't he?

KYLE
I've tried talking to him, but he doesn't want the lawsuits to stop. He's making too much money.

CHEF
Well, somebody ELSE has got to know about all this sexual harassment whosafudge!

KYLE
Hey what about that stupid panda?!

STAN
Yeah, Sexual Harassment Panda is the one that started all this! We have to find him!

CHEF
I hope you do. Otherwise,
(ladling some runny, lumpy taters)
It's lumpy potatoes from here on out.

CARTMAN
AAAGGGH!!!

INT. BOARD ROOM

The same board members from before are gathered around their table.

PRESIDENT
That's thirty-two more Sexual
Harassment Lawsuits in the past twenty-
four hours.

ASSISTANT
Oh my God.

PRESIDENT
Looks like we'll have to cut all
counseling and nutrition programs.

ASSISTANT
The children have started suing
adults... They could sue US next!!

PRESIDENT
Holy smokes! You're right!

The boys walk in.

STAN
Excuse me. We'd like to speak with
sexual harassment panda, please.

PRESIDENT
Agh!

The adults all get behind their chairs. Protecting
themselves from suing children.

PRESIDENT (cont'd)
Please! Don't sue us!

KYLE
Huh?

ASSISTANT
We'll give you anything you want!

STAN
We want sexual harassment panda.

PRESIDENT
Oh no... We uh... We had to let him
go.

CARTMAN
What?!

PRESIDENT
AGH! I mean.. He left.

STAN
Well where is he?

ASSISTANT

We don't know! Honestly! I swear it!
PLEASE let us go!

STAN
What the hell is wrong with these
people?!

INT. OFFICE BUILDING (MOVED)

A suited COMPANY MAN sits at a large desk with his hands
folded.

COMPANY MAN
Well, your credentials are very
impressive, and you do seem to have a
lot of ambition... But I'm afraid
there's no room for you at our company
at this time.

REVERSE shot. Sexual Harassment Panda is sitting opposite
the company man.

Sexual Harassment Panda droops his head.

PANDA
It's because I'm a panda, isn't it?

COMPANY MAN
Well, it is because you're a panda,
yes. It's because you're a SEXUAL
HARASSMENT Panda.

PANDA
I can't help what I am.

COMPANY MAN
Have you ever heard of a retreat
called the 'Island of Misfit Mascots?'

PANDA
Yes... But that place is for LOSER
mascots that make no sense.

COMPANY MAN
Well, yes, they may be just what
you're looking for.

PANDA
I don't have to sit here and listen to
this! How would you like a big panda
punch in your puss?!

INT. NEWSROOM - (MOVED)

A newscaster sits at his desk.

NEWSCASTER

As sexual harassment lawsuits increase all over the State, the mother of all trials is set to begin. The Sexual Harassment case Of EVERYONE vs. EVERYONE begins tomorrow. No matter what the outcome, the public schools are sure to lose at least a whopping thirty MILLION dollars. Representing the side of EVERYONE, is Gerald Broflovski-

A picture of Kyle's Dad appears.

NEWSCASTER (cont'd)
A lawyer from South Park who plans to make quite a commission. Representing the side of EVERYONE ELSE is... Gerald Broflovski-

The picture is replaced by the same picture of Kyle's dad.

NEWSCASTER
So whatever the outcome, things look very bright for Kyle's dad. Personally, I think Kyle's Dad is just a whore, taking advantage of everyone in town and-

A piece of paper flies onto the newscaster's desk.

NEWSCASTER (cont'd)
This just in! Newscaster Kevin McCarty is being sued by Kyle's Dad for slander!

A picture of the newscaster now takes over in the background.

NEWSCASTER (cont'd)
The newscaster has yet to be reached for comment! ...wait...

INT. BAR - DAY

A country SONG plays in the background.

PAN DOWN the bar, lots of regular townspeople are there. STOP on Sexual Harassment Panda, who is slowly drinking a scotch.

BARTENDER
Another scotch?

Sexual Harassment Panda nods. The bartender pours.

Three REDNECKS are at the other end of the bar, staring

at the panda.

REDNECK 1
Hey! Panda Bear!

Sexual Harassment Panda looks down the bar, where the rednecks are still staring.

REDNECK 1 (cont'd)
We don't take kindly to your types here.

BARTENDER
Now, calm down, Skeeter. He ain't hurtin nobody.

REDNECK 1
No! I wanna know something from Mr. PANDA BEAR here...

The Redneck staggers up behind Sexual Harassment Panda.

REDNECK 1 (cont'd)
If you pandas are from mountainous areas of China and Tibet... How come you eat bamboo which is prone to grow only in drier, more arid regions?

The bar gets quiet.

BARTENDER
Skeeter, I don't want no trouble now!

SEXUAL HARASSMENT PANDA
It's okay... I get it... There's no room in the world for Pandas. Well you don't have to worry about me, I'm off to the island of misfit mascots...

Sexual Harassment Panda walks out the door.

BARTENDER
Dammit Skeeter! How come everytime a Panda Bear come in here you gotta go flappin' your jaw!

EXT. KYLE'S NEWER, EVEN BIGGER HOUSE - DAY

The same movers are moving Kyle's family into an even bigger house.

KYLE'S FATHER
Well, what do you think, Kyle?

KYLE
Dad, don't you think our last new house was big enough?

KYLE'S FATHER
Well... This one is BIGGER!

KYLE
Tomorrow's trial, Everyone vs
Everyone, is going to make things a
lot worse. We have to stop it.

KYLE'S FATHER
Kyle, let me explain something to
you...

KYLE
Oh God, here we go.

KYLE'S FATHER
You see, Kyle... We live in a liberal,
democratic society. And Democrats make
sexual harassment laws. These laws
tell us what we can and can't say in
the workplace. And what we can and
can't do in the workplace.

KYLE
Isn't that fascism?

Kyle's dad thinks.

KYLE'S FATHER
No. Because we don't call it fascism.
Do you understand?

KYLE
Do you?

KYLE'S FATHER
Just look at how big this house is
Kyle. Just look at it.

INT. BAR - DAY

Stan, Cartman and Kenny walk into the same bar that
Sexual Harassment Panda was in.

They sit up at the bar and call to the bartender.

STAN
Excuse me...

BARTENDER
Yeah, what can I do you for?

STAN
Somebody told us that they saw a big
panda bear in here.

BARTENDER
(Thinking)
Big Panda Bear... Big Panda Bear...
Hmmm...

REDNECK 1
HEY! EIGHT YEAR OLD!!

The boys look down the bar and see the same rednecks,
sitting there staring.

REDNECK 1 (cont'd)
We don't take kindly to your types in
here.

BARTENDER
Now calm down, Skeeter, they ain't
hurtin' nobody.

REDNECK 1
No! I wanna know something from Mr.
I'M EIGHT YEARS OLD here...

The Rednecks walk behind the boys, who start to look a
little nervous.

REDNECK 1
How come you 'TYPES' are always
wearin' them funny padded shirts in
the winter?

The boys think.

STAN
Coats?

BARTENDER
Now, Skeeter, I don't want no trouble.

REDNECK 2
We don't take kindly to your types
round here!

STAN
Dude, what the hell is going on?

CARTMAN
Did you guys see a big Panda in here
or not?

REDNECK 1
We don't take kindly to Panda Bears!

STAN
Well we don't take kindly to you!

REDNECK 2

We don't take kindly to folks that
don't take kindly round here.

Now everyone looks confused.

BARTENDER

Kids, there was a panda bear in here.
He said something about the island of
misfit mascots.

CARTMAN

Where's that?

BARTENDER

If I'm not mistaken it's over near the
Jenkin's place.

STAN

Come on, we better hurry!

The boys run out. The rednecks all look around, a little
lost. Finally, Skeeter focuses on a hot chick at the end
of the bar.

REDNECK 1

Woa, look at her!
(calling out)
HEY! BEAUTIFUL WOMAN! We don't take
kindly to your types round here...

BARTENDER

Now, Skeeter, she ain't hurtin' nobody-

INT. COURTROOM

The trial of Everyone vs. Everyone is starting.

JUDGE

This is case number 47-G, Everyone vs.
Everyone.

The courtroom erupts again. The judge bangs her gavel.

JUDGE

Representing the side of EVERYONE is
Gerald Broflovski.

Kyle's dad stands.

KYLE'S FATHER

Thank you, your honor. Ladies and
Gentlemen of the jury... Everyone has
committed a crime here, and Everyone
must pay for that crime. My client,
everyone, has been hurt by this crime
and must be compensated.

EXT. ENTRANCE TO ISLAND OF MISFIT MASCOTS - DAY

The boys walk up to a large ranch. The sign outside reads 'Island Of Misfit Mascots Commune'.

PUT KENNY IN THE FIRST FEW SHOTS OF THIS SCENE. HE'S GONNA DIE IN A MINUTE--

STAN
Island of Misfit Mascots Commune. This must be the place.

EXT. ISLAND OF MISFIT MASCOTS - DAY

The boys walk up to a guy in a big stupid worm costume.

WILLY THE DON'T STARE DIRECTLY INTO
THE SUN WORM
Hello there, boys.

STAN
Woa, who are you?

WILLY THE DON'T STARE DIRECTLY INTO
THE SUN WORM
I'm Willy the Don't Stare Directly into the Sun Worm. Now you boys know not to stare directly into the sun, right?

BOYS
Yes.

WILLY THE DON'T STARE DIRECTLY INTO
THE SUN WORM
That can burn your retinas and make you blind.

STAN
Thanks a lot, dude.

A guy in a pig costume walks up.

OINKY THE PIG
Oink! Oink! Be sure you run around with scissors, says Oinky the Run around with scissors pig!

CARTMAN
I thought you weren't supposed to run around with scissors.

WILLY THE DON'T STARE DIRECTLY INTO
THE SUN WORM
That's why he's on the island of misfit mascots.

STAN
Have you seen any panda bears?

WILLY THE DON'T STARE DIRECTLY INTO
THE SUN WORM
Hmmm...

A guy in a big falcon costume walks up.

FALCON
Hey kids, I'm Jimmy the Don't Hold on
to a large magnet while someone else
uses a fan nearby Falcon.

KYLE
What?

FALCON
Here, watch.

The falcon hands Kenny a large magnet and walks over to a
huge, bladed fan.

He switches the fan on, pushes it towards Kenny, and the
magnet causes Kenny to fly into the blades and get cut
into tiny pieces.

FALCON (cont'd)
See?!

STAN
Oh my God! They killed Kenny!

KYLE
You bastard! Hey! There he is!

The boys run over to Sexual Harassment Panda. He is
sitting on a bench looking glum.

PANDA SONG
Who lives in the east
neath a willer tree?
Sexual Harassment Panda!

STAN
Dude, are we glad to find you! You
have to come back to South Park,
quick!

SEXUAL HARASSMENT PANDA
Why?

KYLE
Because everyone is sueing everyone
else and you're pretty much the cause
of it all.

Sexual Harassment Panda lowers his head.

SEXUAL HARASSMENT PANDA
Seems all I do now is cause trouble...

A guy in a badger costume walks up.

BADGER
Hello kids, I'm Hoppy the 'Don't do
Stuff That Might Irritate your inner
ear Badger'

The kids just stare.

BADGER (cont'd)
Well... I'll leave now.

The badger walks away.

STAN
Please, Sexual Harassment Panda,
people listen to you. You have to get
them to stop sueing each other.

SEXUAL HARASSMENT PANDA
But I'm just a panda.

KYLE
NO YOU'RE NOT DUDE! YOU'RE A GUY IN A
PANDA COSTUME!!!

All the mascots GASP.

There is a long, uncomfortable silence.

WILLY THE DON'T STARE DIRECTLY INTO
THE SUN WORM
HEY!! I AM A REAL WORM, PAL!!!

KYLE
Okay sorry... Sorry.

CARTMAN
(Calming him down)
You're a real worm. That's cool,
that's cool.

STAN
Okay, you ARE a panda. But being
sexual harassment panda isn't helping
anyone right now. You used to use your
panda powers to teach people about
sexual harassment... But now you need
to teach a NEW message, a new message
that people will find useful again.

SEXUAL HARASSMENT PANDA

What message?

KYLE

That people shouldn't sue each other
all the time.

Sexual Harassment Panda thinks.

SEXUAL HARASSMENT PANDA

You know... You little cubs might just
be right...

WILLY THE DON'T STARE DIRECTLY INTO
THE SUN WORM

Yeah.

Sexual Harassment Panda stands.

SEXUAL HARASSMENT PANDA

Okay!

INT. COURTROOM

The case of Everyone Vs. Everyone continues. Dog-Poo is
at the stand, surrounded by several other kids and
adults, including Jimbo.

KYLE'S FATHER

Your honor, I'd like to make my
closing arguments-

KYLE

Wait!

The boys rush in with sexual harassment panda.

MR. GARRISON

Hey, it's Sexual Harassment Panda.

STAN

No, he's a whole new panda now, and
he's got something to say...

Everyone quiets down as the camera slowly MOVES IN to
sexual harassment panda.

SEXUAL HARASSMENT PANDA

Hello everyone, I'm Peetie the Don't
Sue People Panda.

JIMBO

Don't sue people panda?

REDNECK 1

HEY! We don't take kindly to folks
that don't sue people round here.

BARTENDER

Now, skeeter he ain't hurtin' nobody.

SEXUAL HARASSMENT PANDA

Listen to me. When you sue somebody it hurts everyone. You sue for money, but where do you think that money comes from? From the schools, from taxes, from the State... From YOU.

Everyone quiets down and thinks.

Don't Sue People Panda Steps Forward.

PANDA

There's no such thing as free money. When you sue somebody, you take money away from parks, and schools and charities and put it in your own pockets. And that makes me a saaaad panda.

The people all think for a while.

TOWNSPERSON

I'm a sad panda too.

TOWNSPERSON 2

I'm a really sad panda...I didn't know we were doing all that damage. This is all that damn LAWYERS FAULT!

Kyle's dad looks nervous.

TOWNSPERSON

Yeah! Let's sue the lawyer!!!!

TOWNSPEOPLE

YEAH!!!

Kyle's dad panics.

KYLE'S FATHER

No!!

Kyle's dad walks over to the panda.

KYLE'S FATHER (cont'd)

Don't' you see? The Panda is right... Boy, what a great message he has. When you sue people, you just end up causing a lot of problems for society... I've really learned something today. All I could see was the millions of dollars coming to me, and I didn't care about where the money came from. Well, I'm no longer

doing sexual harassment lawsuits in schools. They're too vague and too easily corruptible. Thank you, Sexual Harassment Panda!

SEXUAL HARASSMENT PANDA
Don't sue people Panda.

KYLE'S FATHER
Yeah, well, whatever. So, let's not sue anyone again. Okay, come on guys, let's go get some ice cream!

BOYS
Hooray!

SEXUAL HARASSMENT PANDA
Pandas LOVE ice cream!

They walk out.

JUDGE
Well, seeing as we have no lawyers. I'm throwing the case out. Case dismissed!

REDNECK 1
HEY! We don't take kindly to cases being dismissed round here.

BARTENDER
God dammit Skeeter, shut the hell up.

TAG

INT. COURTROOM

Sexual Harassment Panda stands alone, facing the camera.

SEXUAL HARASSMENT PANDA
Hello, cubs! I'm Don't Sue People Panda with an important message for YOU! Lawsuits damage our society. I know its tempting to make money, but just remember, that money has to come from somewhere. And usually it ends up hurting a LOT OF INNOCENT PEOPLE! So until next time - DON'T LET FRIVOLOUS SEXUAL HARASSMENT LAWSUITS RUIN OUR SCHOOLS! Good-bye now!!
